### **Rules for all Classes:**

- Tractors may hook more than once, but not in same weight class.
  - o Puller will identify the weight class they belong in.
  - Puller must sign up for the correct class; No class jumping.
- 1<sup>st</sup> tractor is test puller.
- We may use a speed limit of 8 MPH Wish is to keep the stock class stock.

#### **Stock Rules:**

- The Officials decisions are final.
  - o Arguments with the Officials can result in dismissal from the Fairgrounds.
- One (1) Driver per tractor per class. No Exceptions.
- No leeway on weight will be given in any class.

#### **Tractors:**

- Tractors must be stock in appearance.
  - No Alterations.
  - o All OEM
- Tractors must have working hydraulics and/ or PTO.
- No cut or altered tires.
- No Dual Wheels.

## **Fuels:**

- No alcohol, gasohol or other exotic fuels will be permitted.
- Propane cannot be utilized.
- Diesel tractors must run on diesel only.
  - No Excessive Smoke; Excessive smoke coming from any tractor may be cause for disqualification.
- The 75' Rule will apply except in the event of a pull off in stock class.
  - o In a pull off, the 75' rule does not apply.
- Water Injection is not permitted.

#### Hitches:

- No supports are permitted on a hitch.
- 3-point hitches will not be allowed
- Hitch may only pull straight out from the tractor in the stock location.
- The hitch must be able to hook with official on the sled.
- The maximum hitch of 21" to the top of the bar (not clevis).
- The hitch point must be 3 ¾" from front to back and 3" from side to side

The parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating in the below activity or event, he or she should inspect the facilities and equipment to be used, and if he or she believes anything is unsafe, the participant should immediately advise the officials of such condition and refuse to participate. I understand and agree that, if at any time, I feel anything to be UNSAFE, I will immediately take all precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further.
- 2. I/WE fully understand and acknowledge that:
  - (a) There are risks and dangers associated with participation in Pulling events and activities which could result in bodily injury partial and/or total disability, paralysis and death.
  - (b) The social and economic losses and/or damages, which could result from these risks and dangers described above, could be severe.
  - (c) These risks and dangers may be caused by the action, inaction, or negligence of the participant or the action, inaction or negligence of others, including, but not limited to, the Releasees named below.
  - (d) There may be other risks not known to us or are not reasonably foreseeable at his time.
- 3. I/WE accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis, or death, however caused and whether caused in whole or in part by the negligence of the Releasees named
- 4. I/WE HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the Tioga County Agricultural Society, Inc. Tioga County Fair facility used by the participant, including its owners, managers, promoters, lessees of premises used to conduct the Pulling Events, premises and event inspectors, underwriters, consultants and others who give recommendations, directions, or instructions to engage in risk evaluation or loss control activities regarding the Tioga County Agricultural Society, Inc.
