EVENTS: Barrel racing, straight Barrels, and Keyhole

Barrel Race - The fastest time running the designated pattern. The pattern may be run in either direction. Each barrel knocked over will result in a 5 second penalty. Breaking the pattern will result in disqualification.

Straight Barrels - The fastest time running the designated pattern. The pattern may be run in either direction. Each pole knocked over will result in a 5 second penalty. Breaking the pattern will result in disqualification.

Keyhole - The fastest time running the Designated pattern. If you knock over a barrel A 5 second penalty will be added to your time.

Breaking the pattern will result in a no time.

Tioga County ATV RODEO/ UTV/ Dirt bike Rodeo Rules

- 1. All riders must sign a waiver and all riders under the age of 18 must have a parent sign the waiver also.
- 2. Only low gear is allowed in pit area, and you are only allowed to ride from pit to arena for competition.
- 3. No alcohol will be allowed on the premises; any person who appears impaired will NOT be allowed to compete; anyone intoxicated or under the influence will be escorted off the premises.
- 4. Anyone competing and or operating an ATV, UTV, or dirt bike are required to wear a D.O.T helmet (helmet must be always worn while operating an ATV), eye protection (glasses, goggles, face shield). Riders must wear long pants and shirt. Over the ankle boots must be always worn while operating an ATV. Absolutely no shorts or open toe shoes will be allowed.
- 5. All participants agree to compete in a fair manner and follow all the rules. Unsportsmanlike conduct will NOT be tolerated. All riders will always conduct themselves in a respectful manner. For the safety of competitors and spectators alike there will be no rough housing, no racing, or any unauthorized use of an ATV or dirt bike.
- 6. All riders will control their own machines during operation. If a rider is deemed restless or lacking control, they will be disqualified.
- 7. All riders must follow New York State laws.
- 8. There will be absolutely no pit riding! You will be disqualified without warning and asked to leave the event without refund. No burn outs will be allowed in staging area, or between the staging area and start line. After completing a run riders will immediately proceed to the pit area.
- 9. Anyone with an ATV can participate. More than one participant may use an ATV. It is a competition between the participants NOT the ATV's.
- 10. ATV's cannot be ridden outside the arena, there are no exceptions.
- 11. In case of a breakdown, each rider is responsible for hooking the towrope to his/her machine; any and all damages incurred when being towed are the sole responsibility of the rider.
- 12.. Noncompliance with the rules of this event will result in a disqualification, expulsion, and forfeiture of all fees paid.
- 13. All riders wishing to compete MUST attend the riders meeting before the event begins.
- 14. All decisions made by the panel of judges are final.
- 15. The Tioga County Fair County Fair Board and Directors are not responsible for accidents, injury, or theft of property.

Release and Waiver of Liability and Indemnity Agreement

(Read Carefully Before Signing)

In consideration of being permitted to participate in any way in the Tioga County Agricultural Society, Inc. Tioga County Fair, ATV/UTV/Motorcycle Rodeo Events indicated below and/or being permitted to enter for any purpose any restricted area (here in defined as any area where in admittance to the general public is prohibited), the parent(s) and/or legal guardian(s) of the minor participant named below agree:

- 1. The parent(s) and/or legal guardian(s) will instruct the minor participant that prior to participating in the below activity or event, he or she should inspect the facilities and equipment to be used, and if he or she believes anything is unsafe, the participant should immediately advise the officials of such condition and refuse to participate. I understand and agree that, if at any time, I feel anything to be UNSAFE, I will immediately take all precautions to avoid the unsafe area and REFUSE TO PARTICIPATE further.
- 2. I/WE fully understand and acknowledge that:
 - (a) There are risks and dangers associated with participation in ATV/UTV/Motorcycle Rodeo events and activities which could result in bodily injury partial and/or total disability, paralysis and death.
 - (b) The social and economic losses and/or damages, which could result from these risks and dangers described above, could be severe.
 - (c) These risks and dangers may be caused by the action, inaction, or negligence of the participant or the action, inaction or negligence of others, including, but not limited to, the Releasees named below.
 - (d) There may be other risks not known to us or are not reasonably foreseeable at his time.
- **3.** I/WE accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis, or death, however caused and whether caused in whole or in part by the negligence of the Releasees named below.
- 4. I/WE HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the Tioga County Agricultural Society, Inc. Tioga County Fair facility used by the participant, including its owners, managers, promoters, lessees of premises used to conduct the ATV/UTV/Motorcycle Rodeo Events, premises and event inspectors, underwriters, consultants and others who give recommendations, directions, or instructions to engage in risk evaluation or loss control activities regarding the Tioga County Agricultural Society, Inc. Tioga County Fair facility or events held at such facility and each of them, their directors, officers, agents, employees, all for the purposes herein referred to as "Releasee"...FROM ALL LIABILITY TO THE UNDERSIGNED, my/our personal representatives, assigns, executors, heirs and next to kin FOR ANY AND ALL CLAIMS, DEMANDS, LOSSES OR DAMAGES AND ANY CLAIMS OR DEMANDS THEREFORE ON ACCOUNT OF ANY INJURY, INCLUDING BUT NOT LIMITED TO THE DEATH OF THE PARTICIPANT OR DAMAGE TO PROPERTY, ARISING OUT OF OR RELATING TO THE EVENT(S) CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE RELEASEE OR OTHERWISE.
- **5.** I/WE HEREBY acknowledge that THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.

- **6.** EACH OF THE UNDERSIGNED further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the Province or State in which the event is conducted and that if any portion is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.
- 7. On behalf of the participant and individually, the undersigned partner(s) and/or legal guardian(s) for the minor participant executes this Waiver and Release. If, despite this release, the participant makes a claim against any of the Releasees, the parent(s) and/or legal guardian(s) will reimburse the Releasee for any money which they have paid to the participant, or on his behalf, and hold them harmless.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
