

**Tioga County Fair Camping Rules, Regulations, and Disclaimers**

1. Campers shall arrive before NOON, On Monday before fair start and removed by Monday fair end. Campers cannot be removed during the fair. (Elm Street entrance only) and check in at the fair office. Speed limit is 5MPH
2. **All campers must access the campgrounds through Elm St.** All other gates will not be accessible to the campgrounds. Vehicles with the "Camper Vehicle Parking Permit" will be the only vehicles allowed access to the campgrounds. All others must park in the general parking lots. NO stock trailers are allowed in camp area, parking for stock trailers will be in the overflow parking field.
3. All camping permit cards must be visibly displayed in window of camper adjacent or nearest to the door. Dogs and other pets are not allowed on the grounds or on campsites. No visitors are allowed unless they have a fair pass.
4. No electric cords are to run across roadways and only ONE electric outlet allowed per camping lot.
5. No alcoholic beverages are permitted on the fairgrounds.
6. 11:00 pm- 8am will be quiet time.
7. **Quite Generators are allowed however Decibel ratings may not be over 50.** Anyone found not in compliance will be asked to leave
8. All trash must be placed in dumpster before 9:00 AM daily.
9. **Only ONE vehicle is permitted to park on the lot,** and this vehicle must display the parking permit. Additional vehicles must be parked in the general parking lots. This rule will be strictly enforced.
10. **Dumping gray water and sewage on the ground is forbidden.** Anyone found abusing this rule will forfeit their camping privileges.
11. You must be 21 years of age to register as a camper, and you will be responsible for all occupants and guests.
12. Camper is responsible for keeping your campground site and all fixtures in clean and safe condition. You must remove all garbage, rubbish and other waste in a clean and safe manner, to the place provided by the Fairgrounds. You will use all electrical, plumbing and other facilities and appliances in a reasonable manner. You will not destroy or damage any part of the campgrounds.
13. Golf Carts, motor bikes, E-bikes, atv's, recreational or similar motorized vehicles are **prohibited.** Handicap exemptions
14. While the camping vehicle and other personal property is on the campsite, or in storage, Tioga County fair disclaims any representation, warranty or guarantee as the safety of the storage are for said vehicle. The Tioga County Fair assumes no responsibility for damage to your trailer or camping vehicle for any reason including but not limited to vandalism, natural causes or acts of God. We assume no responsibility for proper or necessary maintenance of your trailer or camping vehicle during the term of your agreement, this being your responsibility.
15. Camper does forever release, acquit and discharge The Tioga County Agricultural Society and each of its respective subsidiaries, affiliates, divisions, officers, directors, employees, agents, successors, and assigns, both their official and personal capacities, whichever may be applicable, from any and all claims, demands, judgments.
16. **No wood fires are permitted**
